

Privacy Statement

SCOPE AND PURPOSE

This policy applies to how Advanced Sensors Limited (Advanced Sensors) processes personal data and personal information of our employees and where applicable, our customers. All supervisors are responsible for enforcing this policy and our employees are trained to be familiar with and comply with Advanced Sensors's data privacy policy and procedures.

The purpose of this policy is to inform employees and customers of the principles under which Advanced Sensors processes personal data and personal information.

Advanced Sensors is a privacy conscious organization and is committed to your personal right to privacy. We only collect personal information that is specifically and voluntarily provided by a user to us. A visitor may choose to become a user and provide information to register for ordering goods or services, or to apply for a job using our career portal. When we receive identifiable information from a user we use it solely for the purpose for which it was provided and secure your information as required by law.

VISITORS TO OUR WEBSITE

Where visitors to our website choose to provide us with a name, e-mail address, or other information, they become potential customers of Advanced Sensors:

- Advanced Sensors will use your information solely for the purpose for which it was provided.
- We will only use and disclose your information in accordance with your permission.
- We will let you change your information so that you can keep it up to date.
- We do not give your personally identifiable information to advertisers.
- We do not sell or rent your private information to third parties.

PRIVACY PRINCIPLES

In processing personal data, Advanced Sensors complies with the following principles. Adherence to the principles may be limited to the extent to meet national security, public interest, law enforcement and other legal requirements and obligations.

Notice: Where Advanced Sensors collects personal information directly from individuals, it will inform them about the purposes for which it collects and uses such personal information, the types of third parties to which Advanced Sensors discloses that information, and the choices and means, if any, Advanced Sensors offers individuals for limiting the use and disclosure of their personal information. Notice will be provided in clear and conspicuous language when individuals are first asked to provide personal information, or as soon as practicable thereafter, and in any event before PAC uses the information for a purpose other than that for which it was originally collected.

Choice: Advanced Sensors will offer individuals the opportunity to choose (opt-out) whether their personal information is (a) to be disclosed to a third party, or (b) to be used for a purpose other than the purpose for which it was originally collected or subsequently authorized by the individual.

Data Integrity: Advanced Sensors will use personal information only in ways that are compatible with the purposes for which it was collected or subsequently authorized by the individual. Advanced Sensors will take reasonable steps to ensure that personal information is used for its intended purpose, and is accurate, complete, and current.

Onward Transfers: Advanced Sensors may transfer information to a third party acting as an agent or business partner of Advanced Sensors by making sure that the third party enters into an agreement with PAC in which the third party promises to provide similar protection as Advanced Sensors' privacy policy. Occasionally, Advanced Sensors may also be required to disclose certain personal data to other third parties as a matter of law; to protect Advanced Sensors' legal rights; or in an emergency where health or security of an individual is endangered.

Access and Correction: Upon request, Advanced Sensors will grant individuals reasonable access to personal information that Advanced Sensors may hold about them. In addition, Advanced Sensors will take reasonable steps to permit individuals to correct, amend, or delete information that is demonstrated to be inaccurate or incomplete.

Security: Advanced Sensors will take reasonable precautions to protect personal information in its possession from loss, misuse, and unauthorized access, disclosure, alteration, and destruction.

Enforcement: Individuals may contact Advanced Sensors at ContactHR@paclp.com in order to register complaints, to submit access requests, or to address any other issues under the privacy policy.

Dispute Resolution: Any questions or concerns regarding the use or disclosure of personal information should be directed to Advanced Sensors at the address given below. Advanced Sensors will investigate and attempt to resolve complaints and disputes regarding the use and disclosure of personal information in accordance with the principles contained in this policy.
